Early Work on Technical Training Center Considered in Kenya

Martin Oranja of Kenya has been appointed as a new Task Force leader for Medical Technical Training Development for AHHF. Martin is an Ascension Associate in the Finance Department, and his family is also from Kenya. Martin's wife's father, Mr. Livingstone Sane, is a well known highly regarded attorney with many ties to Governmental agencies and officials in Kenya, and at a meeting of Jeff, Jill Martin, Mr. Sane and his wife, it was decided to pursue possible creation of a school to train technicians to repair and utilize donated or existing medical equipment at East African Health facilities. Potential avenues of acquiring or leasing land in Kenya Maasai Land for the housing of a such a school might also be used to temporarily warehouse equipment and provide

on-site faculty and student living while in session.

Mr. Sane has returned to Kenya and is in early stages of the investigation which is to be brought before the BOD at their next meeting. Consideration of other school affiliation, the financial feasibility of doing such work and Kenya law are all items for discussion.

Educational Task Force Established



Investigations and meetings of the Executive Director and CEO with members of the Senegalese and Congolese communities in Saint Louis suggest this as a strong possibility for the future, taking maximum advantage of medical supply shipments to East Africa that should be ongoing.
